BACKGROUND:

- 1. AFL Queensland (AFLQ) is the State Level Organisation responsible for the growth and development of Australian Football throughout the state.
- 2. Ms Trisha Squires is the current Head of AFLQ and Mr Darryl Bray is the President of the organisation.
- 3. AFL membership in Queensland has exceeded pre-COVID rates with 33 815 participants in 2021.
- 4. AFLQ has 141 clubs operating across Queensland.

KEY ISSUES:

Support for the activity of AFL

- 5. Since 1 January 2015, DTIS has approved total funding of \$46.3 million towards the sport of AFL in Queensland of which \$6 572 000 was directly to AFL Queensland Ltd:
 - \$40 502 806 towards capital projects
 - \$3 767 416 towards non-capital projects
 - \$2 074 412 towards individuals.
- 6. The above investment includes:
 - \$4 million for the AFL Grand Final Infrastructure Legacy Fund to 2023, in partnership with AFLQ, to enhance AFL facilities across the state. This funding will assist grassroots community football clubs, local Councils and AFL umpiring organisations to deliver AFL projects across Queensland, such as improved lighting, female friendly facilities and upgraded fields of play.
 - i. To date, the Steering Group for the AFL Grand Final Legacy Fund (the Fund) has endorsed projects to a value of over \$2 826 000.
 - ii. The Fund is intended to assist grassroots community football clubs, local councils and umpiring organisations, with grants of up to \$100 000 to develop Australian rules football facilities across Queensland. Co-contributions from clubs is also encouraged.
 - iii. Ultimately, the Fund seeks to encourage and inspire more Queenslanders to be physically active through the provision of fit for purpose places and spaces. This aligns with one of the core objectives of the Queensland Government's *Activate! Queensland* 2019-2029 strategy.

BACKGROUND:

- 1. The Department of the Premier and Cabinet has requested input to support preparation of materials for the Premier attending and officially opening the Brisbane Lions Springfield facility on Sunday 4 December 2022.
- The Brisbane Lions was formed in late 1996 via a merger of the Melbourne based 1883 foundation VFL club the Fitzroy Lions, and the 1987 Queensland based expansion club the Brisbane Bears, with the colours of maroon, blue, and gold being drawn from both parent clubs.
- Located at Springfield, the Brisbane Lions project is a new \$82.1 million boutique stadium to support the AFL Women's competition in Queensland and to be a home for the Brisbane Lions for administration and training purposes.
- 4. In addition to the stadium, an indoor training facility, a fully functional gym, and an administration centre for the Brisbane Lions has been built.
- 5. The Queensland Government, through the Department of Tourism, Innovation and Sport (DTIS), has provided \$18 million towards the development.
- 6. Additional financial commitments towards the delivery of the development include:
 - Australian Government \$15 million
 - Ipswich City Council \$20.4 million (includes Fit-for-Purpose Works valued at \$6.4 million)
 - AFL and Brisbane Lions \$23.7 million
 - Commercial partner (Gym JV) s.73 of the R.
- 7. The project commenced construction in September 2020 and achieved practical completion on 14 October 2022. Hutchinson Builders are the principal contractor.

KEY ISSUES:

- 8. The Brisbane Lions held a soft opening of the facility with project financial partners on 18 October 2022 including the Honourable Stirling Hinchliffe MP, Minister for Tourism, Innovation and Sport and Minister Assisting the Premier on Olympics and Paralympics Sport and Engagement.
- 9. The Brisbane Lions are partnering with Multicultural Australia who will co-locate at the new facility to run its Queensland operations.
- 10. At the sod turning event for the project, the Brisbane Lions announced that it would be called Brighton Homes Arena.
- 11. The Brisbane Lions recently announced that the playing field is named "Michael Voss Oval".
- 12. The Brisbane Lions WAFL team is currently on top of the competition ladder.

- 13. Since 1 January 2015, DTIS has approved total funding of \$46.3 million towards the sport of AFL in Queensland of which \$6 572 000 was directly funded to AFL Queensland Ltd (AFLQ):

DOT POINT BRIEF – MINISTER

SUBJECT: Minister attending official opening of Brighton Homes Arena, 27 November 2022

BACKGROUND:

- 1. Located at Springfield, the Brisbane Bears-Fitzroy Football Club Limited (Brisbane Lions) proposed to develop a new boutique stadium, officially named Brighton Homes Arena, for the purpose of supporting the Australian Football League Women's competition in Queensland.
- 2. In addition to the stadium, an indoor training facility, a fully functional gym, a childcare centre and an administration centre for the Brisbane Lions, was proposed.
- 3. On 5 September 2019, the Governor in Council approved \$15 million in funding to the Brisbane Bears Fitzroy Football Club Limited (Brisbane Lions) to develop a new boutique stadium at Springfield for the purpose of supporting the Australian Football League Women's (AFLW) competition in Queensland.
- 4. In October 2020, the Queensland Government made an additional financial commitment of \$3 million.
- 5. In July 2022, AFL advised the Department of Tourism, Innovation and Sport (DTIS) the total estimated project cost was \$82.1 million.
- Contributions have also been committed from the Australian Government, Ipswich City Council (including developer contributions and in-kind fit-for-purpose bulk earthworks), the AFL and Brisbane Lions and commercial partner Gym JV towards delivery of the project.
- 7. The full \$18 million of the Queensland Government funding has been paid.
- 8. The project achieved practical completion on 14 October 2022, and a soft opening was held on 18 October 2022 with key project partners.
- 9. The official opening was planned to be held as a community day on Sunday 4 December 2022 but will now coincide with the AFLW Grand Final event with the Honourable Annastacia Palaszczuk MP, Premier and Minister for the Olympics to also attend.
- 10. Talking Points, Fast Facts, Questions and Answers and a Media Release have been prepared for the Minister (Attachments 1-4).
- 11. A copy of the speech drafted for the Premier for the event is at Attachment 5.

KEY ISSUES:

- 12. The stadium is the first elite team sports facility in Australia to provide elite training facilities for professional men's and women's teams.
- 13. The facility will help enhance the competitiveness of Brisbane's teams in the Australian Football League (AFL) and AFLW competitions.
- 14. The stadium will assist in resolving ongoing match scheduling challenges at the Brisbane Cricket Ground and ensure AFLW athletes, officials and spectators are not resigned to using low-capacity community venues, as women's sport continues to grow in prominence across Queensland.
- 15. The boutique arena at the stadium will also provide South East Queensland with a suitable venue for staging AFL pre-season and AFLW matches.
- 16. With the Lions AFLW team progressing to the Grand Final, the AFL in collaboration with the Lions have announced for the Grand Final to be held at Brighton Homes Arena on 27 November 2022.

- On AFLW Grand Final Day The Lions v Melbourne Demons at 1.40pm, right here in Springfield.
- A purpose-built stadium that sets a new benchmark for women's sport in Australia as the country's first team sports centre to provide elite facilities for men and women.
- A new home for the Brisbane Lions AFLW team and Lions administration base.
- A training and practice match space for the Lions men and Lions Academy boys and girls and a valuable hub for AFL Queensland finals, representative matches, school programs and community events.
- The Lions AFLW team and Lions staff have already moved in while the Lions men's team will move in on 5 December after they return from leave.

The project

 A boutique stadium surrounding Michael Voss oval – triple Premiership winning Lions captain – along with a second full size playing field.

- A health and fitness centre (gym) and wellness facility with infrared saunas, float tanks, a lap pool and aquatic recovery pool that is accessible for the whole community so you can train alongside your heroes.
- The first same-sized standalone male and female change rooms, an events lawn, administration centre, meeting rooms and auditorium.
- Ipswich City Council led delivery of the fit-for-purpose bulk earthworks in 2020, then Hutchinson Builders began work in April 2021 and finished in October 2022, supporting over 260 full-time jobs during construction, plus ongoing jobs for catering, maintenance and administrative staff.
- The Arena was designed by local architects Populous.

The benefits

- More Queenslanders will be encouraged to get active, both out on the field and in the community health and fitness centre.
- Young Queensland footy players will be inspired to reach the top, especially girls who now have a boutique stadium and premium training facilities should they reach AFLW level.
- The stadium can be potentially used for Lions games during the 2023 FIFA Women's World Cup and while the Gabba is being redeveloped for Brisbane 2032, as the capacity can be expanded to 25,000 with temporary seating added.
- Community-use facilities provide an extra revenue stream for the Lions.
- An economic boost for the region as the Arena will be a drawcard for more carnivals, matches and events.
- Could be used for modern pentathlon at Brisbane 2032.

 - So far projects worth more than \$900,000 have been approved.
 - It includes improved lighting, female-friendly change rooms and upgrading playing fields.
- And \$18 million to help build Brighton Homes Arena.
- There was also an additional \$6.5 million approved to support AFL Queensland operations, since 2015.

Brisbane Lions

EVENT/TOPIC: Brighton Homes Arena opening

What is Brighton Homes Arena?

An \$82.1 million, 10,000-capacity AFL stadium (more during major events like AFLW Grand Finals) and high-performance training centre at Springfield Central. It is Australia's first team sports centre with elite facilities for both men and women. There is two AFL fields planned, including the main oval – Michael Voss oval. There is an indoor training centre with a 50-metre indoor training field and kick room. A health and fitness centre and wellness facility with infrared saunas and float tanks. A lap pool and aquatic recovery pool, male and female change rooms, an events lawn, administration centre, meeting rooms and auditorium.

Who will use the facility?

The Brisbane Lions AFLW team will train and play their games at the Arena. It will be used by the Brisbane Lions as an administration base and by the Lions men as a high-performance training centre and for playing practice matches. The Lions Academy boys and girls will also be able to use the facilities which can host AFLQ finals, school carnivals and representative fixtures. All the indoor facilities can be used by the community and the fields used for events and gala days.

The Lions have partnered with Multicultural Australia who will utilise the facility as their home base in Queensland.

Why did you build the stadium?

To cater for the rapid growth in participation of women's sport in Queensland, which has culminated in the AFLW competition becoming more professional and popular. To improve the pathways to the top for talented boys and girls and provide an economic boost for the region. The Arena will inspire more Queenslanders to lead active, healthy lives, especially when members of the public can train alongside some of their heroes.

Who paid for it?

The \$82.1 million stadium was funded by the Queensland Government (\$18 million), and contributions also were provided by the Federal Government, AFL/Brisbane Lions, Ipswich City Council (including in-kind fit-for-purpose bulk earthworks) and commercial partners Gym JV.

Who built it?

Hutchinson Builders, supporting over 260 full-time equivalent jobs during construction. The stadium was designed by local company Populous.

How many people play in the AFLQ competition?

There are 265,760 Queenslanders who participate in AFL, an increase of 47.5% over five years. This is made up of 154,118 males and 111,642 females – 42% females which is the largest proportion in Australia. There are more than 30,000 people in 141 clubs across Queensland who currently play club football each week in Queensland. Registered participation is more than 58,000 which is a new record and higher than before COVID. Female participation in AFL in Queensland has increased by 331% since 2014.

Questions and Answers

EVENT/TOPIC: Brighton Homes Arena opening

Why has the number of female players grown so much?

There are a lot more introductory programs in schools, and the number of female and mixed junior teams has grown since the introduction of the AFLW competition in 2017 and the success of the Brisbane Lions and Gold Coast Suns women's teams. There are also more female-friendly change rooms and facilities to cater for women and girls, and a greater awareness of the opportunities for girls to play footy with their friends.

How does the Queensland Government support AFL?

The Queensland Government has approved more than \$46 million to support the sport of AFL in Queensland since 2015, including more than \$40 million for capital works projects like Bright Homes Arena. Other programs include Active Clubs, Disaster Recovery, Emerging Athlete Pathways, travel subsidies, school sport programs and FairPlay vouchers. The AFL Grand Final Infrastructure Legacy Fund is seeing the AFL and Queensland Governments jointly contribute \$4 million towards enhancing lighting, change rooms and playing fields across the state.

Why should people play AFL?

People can play, or volunteer as coaches, officials, managers or canteen helpers. It all helps our local community sporting clubs to thrive and enables you to get engaged in a fun activity that is good for your physical and mental health.

How good are the Brisbane Lions AFLW side?

They won the 2021 AFLW Premiership after defeating the Adelaide Crows by 18 points in the Grand Final at Adelaide Oval, before Adelaide won the Premiership at the start of 2022. The team also won the minor premiership in the second comp at the end of 2022, gifting them a home Grand Final at Brighton Homes Arena against the Demons.

Brighton Homes Arena opens on AFLW Grand Final day

The \$82.1 million Brighton Homes Arena that includes a high-performance training centre will officially open to the public at Springfield on Sunday 27 November to coincide with the Lions playing Melbourne in the AFLW Grand Final.

Sport Minister Stirling Hinchliffe said this is a unique chance for the public to be part of history with the opening of Australia's first ever purpose-built stadium designed for a professional female sports team to reside, as the Lions chase an AFLW Premiership on home soil.

"Brighton Homes Arena is the nation's first team sports facility that provides elite training facilities for both professional men's and women's teams and the Lions AFLW side will test it out for the first time in a Grand Final," said Minister Hinchliffe.

"The Brisbane Lions staff and AFLW team have already moved into the facility while the Lions men's team will join them after they come back from leave on 5 December to make Springfield their full-time training headquarters.

"There is a 50-metre indoor training field and kick room, gymnasium, infrared saunas, float tanks, lap pool, aquatic recovery pools, same-sized standalone male and female change rooms, an events lawn and administration centre and auditorium.

"The stadium is also the first completed Olympic venue since the Brisbane 2032 announcement, with the venue earmarked as a potential host for modern pentathlon during the Games."

Brighton Homes Arena was designed by local architects Populous and built by Hutchinson Builders, supporting over 260 jobs during construction.

Minister Hinchliffe said the stadium can also be used for AFL Queensland finals, representative matches and school programs across two ovals – the main stadium overlooking Michael Voss oval, named after the Lions' triple Premiership winning captain.

"Women and girls who play AFL and Lions Academy boys and girls from across Queensland now have the ultimate incentive to make it to the top with a boutique stadium they can aspire to play at on a regular basis," he said.

"The health and fitness centre, pool and wellness facilities will be accessible for the whole community so you can train alongside your heroes.

"This arena will be a valuable community space for the Ipswich region, encouraging more Queenslanders to get active while improving development pathways and boosting the economy.

"We could also see the Lions playing AFL Premiership games here next year when the FIFA Women's World Cup comes to Brisbane and when The Gabba is redeveloped for Brisbane 2032."

Queensland Government funding in AFL

Since 2015, my Government has provided more than \$46 million in funding towards AFL in Queensland.

We've provided \$4 million, in partnership with AFL Queensland through the AFL Grand Final Infrastructure Legacy Fund, to assist grassroots community clubs, local Councils and AFL umpiring organisations.

Over the past five years, there's been a 47.5 per cent growth in AFL participation in Queensland, including school sports.

This is driven mainly by increases in school introductory programs and the exponential growth in female involvement, which represents 42 per cent of all AFL participants in Queensland.

This is the largest percentage of female players nationally.

This emphasises the importance of my Government's funding in AFL, alongside the success of the Brisbane Lions women's team and the AFLW as a competition.

And also the great work of AFL Queensland, which helps clubs with costs, provides access to better facilities and is increasing opportunities for women and girls.

AFL Queensland's pathway to elite success is clearly working, with the Brisbane Lions hoping to claim its second AFLW Premiers this afternoon.
